

# Business Card Drop Drawing - Official Rules

NO PURCHASE NECESSARY OR PAYMENT REQUIRED TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

## 1. Sponsor

The Ahern Canada™ Business Card Drop Drawing is sponsored by Ahern Canada, 15730-118 Ave Edmonton, AB T5V 1C4 (“Sponsor”).

## 2. Eligibility

The Ahern Canada™ Business Card Drop Drawing (“Drawing”) is open only to legal residents of Canada who are 18 years of age or older as of January 1, 2017, and who have validly entered the Drawing. Residence of Quebec, Canada are excluded from this contest. The winner must undergo a skill testing question in order to qualify to receive prize. At the Announcement, an authorized representative of Sponsor will choose one (1) business card at random from the drop box used during the Drawing.
